### Specifics of the Addendum:

## **CLARIFICATIONS – ADA COMPLANCE:**

Please refer to the following text and attached photo contained in the pdf file for ADA compliance clarifications on the specified sign:

The sign is comprised of three (3) primary components: Lexan back plate, SSADA thermoformed copy, & Lexan front plate. The Lexan Front Plate covers the entire sign, with the exception of the SSADA section of the SSADA section to be exposed. The SSADA section therefore remains a tactile layer.

In addition, the <u>government Access Board has responded to our inquiry regarding</u> ADA compliance of the signs in question and they have confirmed that the sign is ADA compliant.

Per the Access Board: "Nothing in the ADA Standards controls the height of raised borders or decorative elements."

## PART 3 – EXECUTION

- c) Exterior Roof Facia Main Building Sign
- ii) Mounting Method is intended for mounting the aluminum bar with letters on the metal facia of the roof using exterior grade hardware.
- iii) Refer to the Main Building Exterior Sign Drawing for Install Location
- iv) Method
  - (I) Installer to take field measurements to ensure proper fit.
  - (2) Mounting surface must be clean and dry to insure good adhesion.
  - (3) Installer to utilize templates provided by manufacturer.
  - (4) Install sign using extra-long hardware that is necessary to penetrate the 5/16" thick nonstructural metal panel with 1 ½" air space to affix the bar to the treated plywood substrate. The hardware must be stainless steel, galvanized steel, chrome plated or other noncorroding metal and concealed.
  - (5) Check for level, and apply firm pressure to fasteners for good adhesion

All other terms and conditions of the original Invitation for Bids shall remain the same. This notice shall be signed and attached to the Invitation for Bids and shall form a part of your bid.
