NOTICE OF FINANCE COMMITTEE CONFERENCE CALL AND VIDEO CONFERENCE MEETING

WHEREAS, the Dormitory Authority of the State of New York has scheduled a Finance Committee Conference Call and Video Conference Meeting on July 14, 2020 at 4:00 p.m., or as soon thereafter as proceedings may commence; and

WHEREAS, on March 7, 2020, Governor Andrew M. Cuomo declared a disaster emergency in the State of New York due to the outbreak of the novel coronavirus, COVID-19, which was designated by the World Health Organization as a Public Health Emergency of International Concern on January 30, 2020 and as a public health emergency for the entire United States by the United States Health and Human Services Secretary on January 31, 2020; and

WHEREAS, on March 12, 2020, Governor Cuomo issued Executive Order 202.1 (as extended by Executive Order 202.14 dated April 7, 2020, Executive Order 202.28 dated May 7, 2020, Executive Order 202.38 dated June 6, 2020 and Executive Order 202.48 dated July 6, 2020) which, *inter alia*, suspends Article 7 of the Public Officers Law (known as the Open Meetings Law), to the extent necessary to permit any public body to meet and take such actions authorized by the law without permitting in public in-person access to meetings and authorizing such meetings to be held remotely by conference call or similar service, provided that the public has the ability to view or listen to such proceeding and that such meetings are recorded and later transcribed; and

WHEREAS, Section 3.7 of the DASNY Bylaws (Meetings by Video or Telephone Conference) provides, *inter alia*, that to the extent permitted by law, meetings of the DASNY Board may be conducted by telephonic and/or video conference in accordance with the provisions of this section except that (i) the place of the meeting shall be a place at which one or more of the participants shall be located; and (ii) the participants at the different locations need only be able to hear one another; and

NOW, THEREFORE, PUBLIC NOTICE IS HEREBY GIVEN THAT a Finance Committee Conference Call and Video Conference Meeting will be held on Tuesday July 14, 2020 at 4:00 p.m., or as soon thereafter as proceedings may commence. At the aforesaid time and date, members of the public shall have the opportunity to listen to the proceedings telephonically by dialing in to the following access line or view the proceedings by video using the following link:

Due to the pending public health emergency, and in conformance with Executive Order 202.1 (as extended) and other applicable law, no in public in-person access to the meeting will be allowed. A transcription of the proceedings will be prepared and posted as soon thereafter as is reasonable and practicable under the circumstances.
