Minutes of HECap Board Meeting August 6, 2009

The Higher Education Capital Match Program ("HECap") Board met by video conference in the conference rooms of the Dormitory Authority of the State of New York's Albany and New York City offices on August 6, 2009 at 3:00 pm.

The Meeting was called to order by Mary Beth Labate, Chair Designee and a quorum was present. Those Members present for the Meeting were as follows:

Ms. Labate called the meeting to order. She noted that Assemblymember Glick was participating from the Dormitory Authority's New York City office (NYC Office). Ms. Labate welcomed newly appointed Board member, Christopher Erikson, to the Board. Ms. Labate also welcomed Senator Toby Stavisky to the meeting. She noted that the Dormitory Authority serves as staff to the HECap Board and introduced Debra Pulenskey Drescher, Esq., Managing General Counsel of the Dormitory Authority, to outline the status of projects to date. Ms. Drescher first introduced Authority staff working on this program: Catherine Tully, Senior Counsel of the Dormitory Authority and Sarah D. Antonacci, Grant Administrator. Also attending from the Dormitory Authority where Sara E. Stein, Environmental Manager and Charles M. Samul, Director, Client Outreach.

Ms. Drescher explained that to date, forty (40) projects totaling \$52 million dollars for thirty-three (33) schools have been approved by the HECap Board. She stated that Grant Disbursement Agreements ("GDAs") have been forward to all of the approved applicants, the majority of the contracts have been executed, and requisitions for payment are being paid by the Office of the State Comptroller. Ms. Drescher stated that before the Board for consideration are forty-eight (48) projects for thirty-nine (39) schools totaling \$58 million dollars.

Ms. Labate thanked Ms. Drescher and proceeded to present the following Resolutions to be acted upon by the Board:

The first resolution was the election of a Chair of the HECap Board. A motion was made by Mr. Erikson to elect Ms. Labate the Chair of the HECap Board, seconded by Assemblymember Glick. All voted in favor.

Ms. Labate presented the Minutes of the April 30, 2008 meeting and asked if there were any comments or corrections. None being noted, a motion was made by Mr. Erikson to adopt the Minutes, seconded by Assemblymember Glick. All voted in favor.

Ms. Labate requested that Ms. Drescher explain the Resolution adopting the determination made under SEQRA for the forty-eight (48) projects totaling over \$58 million that are under consideration by the HECap Board. Ms. Drescher explained the action before the Members is a Resolution of the Board adopting the State Environmental Quality Review Act ("SEQRA") findings on the list of projects attached to the Resolution. She explained that this list sets forth the environmental findings for each of the projects that was undertaken by the Environmental Affairs unit of the Dormitory Authority. A motion was made by Assemblymember Glick to adopt the resolution and was seconded by Mr. Erikson. All voted in favor.

The final resolution approving forty-eight (48) projects totaling over \$58 million and allowing the Dormitory Authority to enter into one or more agreements with the higher education institutions was considered. Ms. Labate requested Ms. Drescher to provide a brief overview of due diligence undertaken with respect to the projects before the Board for consideration. Ms. Drescher explained that staff had completed its review with respect to statutory and program compliance, categorization with respect to the State Environmental Quality Review Act, and an initial review of the projects for compliance with federal tax laws for the purpose of permitting the Dormitory Authority to reimburse the State through the issuance of tax-exempt bonds.

A motion was made by Mr. Erikson to adopt the resolution and seconded by Assemblymember Glick. All voted in favor.

Ms. Labate again thanked Authority staff for the work undertaken to date and recapped by stating that as a result of this Board meeting the HECap Board will have approved eighty-eight (88) projects totaling over \$110 million from the \$150 million previously authorized for the program. She also stated that the HECap Board is committed to working with staff to complete its review of the remaining sixty-five (65) projects, including those requesting a waiver. She

stated that the Board is also committed to addressing the potential redistribution of the unused grant allocation as soon as possible.

Motion to adjourn was made by Assemblymember Glick and seconded by Mr. Erikson. Meeting was adjourned at 3:10 pm.
