The scoring matrix says Site Control is pass/fail: either it's sufficient to award, or it's insufficient and the Grant cannot be awarded. The RFA also suggests that number of other items will be factored into these 10 points, like possessing construction documents, zoning approvals, and executed contracts, but these are not listed in the matrix. While we plan to provide as much information as we can to strengthen our application, it doesn't seem that they're considered in the scoring. Can the scoring for Construction Readiness please be clarified? This also seems to be an issue with the scoring matrix for BRICKS.	NYS SWIMS Team Answers The Scoring Matrix has been updated to ensure the 4 total points are available. Site Control: This is a pass/ Fail requirement. If you do not provide a form of site control listed in Section 4.3 in the RFA you will not move on to Scoring. Therefore, there are no points involved in Site Control. Please refer to the Construction Readiness and Financial Review Sections of the scoring matrix. The zoning approval would be included in Number 4 & 5 of Construction Readiness. Construction documents and contracts would be included in #1 of Financial Review Section of scoring.

Our pool happens to be surrounded by Census Tracts that represent the true population of the City of Tonawanda - high levels of poverty - but it's central location (middle of three Census Tracts in our boundaries) has lower levels of poverty. If you're unable to fill in the application electronically you can print it out and fill it out by hand. You must then scan it back to yourself and send it via email with your other documentation.
Other	Does a "non-pool applicant" that is planning to secure a partner to run and manage the pool need to have the partner secured at the time the application is submitted? Or is a demonstration of a search process adequate?	If a municipality or not-for-profit entity intends to hire an outside manager to facilitate operations of their swimming facility, that is not prohibited. However, the applicant entity must maintain full site control of the facility. They cannot transfer site control, either by sale or lease to another organization and the swimming facility would have to retain its public purpose as described in the application. The executed contract with a manager would not necessarily be required with the application for the construction of a new swimming facility, but the use of one should be disclosed as part of the project narrative. In this case, the construction would happen on land owned by the community college, but the pool expansion project is a joint venture between the YMCA and the college.
