

ADDENDUM NO.: 2 IFB or RFP NO.: 721 Description: Furnish and Deliver Audio/Video Equipment Project: Westchester Community College – Yonkers Extension Center Bid Opening Date: April 14, 2022

Specifics of the Addendum: Revise the Notice and Information for Bidders Sections 11.0 and 12.0, revise Attachments A, B and C to the Notice and Information for Bidders and provide Responses to the Requests for Information.

- 1. Notice and Information for Bidders Section 11.0 is amended to exclude the requirements for insurance, as noted under the required Contract Forms.
- 2. Notice and Information for Bidders Section 12.0 is amended to exclude the requirement for prevailing wage, as the installation scope has been removed.
- 3. Attachment A: Bid Breakdown & Schedule is amended to remove the line item for Bonds and to remove the line item for the cost of installation. All items previously associated with installation are now listed as "not applicable". An amended version of Attachment A to the Notice and Information for Bidders is included as part of this Addendum.
- 4. Attachment B: Detailed Specifications is amended to update quantities on certain items, and to add new items to the list of equipment. An amended version of Attachment B to the Notice and Information for Bidders is included as part of this Addendum.
- 5. Attachment C: Scope of Work and Site Logistics is amended to remove the installation services from the scope and require the Bidder to furnish and deliver the equipment only. An amended version of Attachment C to the Notice and Information for Bidders is included as part of this Addendum.

Below are the Responses to the Requests for Information:

1. Electrical Drawing E-300 has a matrix of delineation of responsibilities that conflicts with Attachment A, therefore, we have the following questions:

1aQ. Is the AVC Furnishing all of the AV equipment listed in the specifications & scope of work? 1aA. Yes.

1bQ. IIs the AVC Furnishing all of the low voltage AV cabling (speaker and CAT6)? **1bA. Yes.**

1cQ. Is the AVC Installing all of the low voltage AV cabling (speaker and CAT6)? **1cA.** Yes.

1dQ. Is the AVC furnishing and installing the cable connectors? **1dA. Yes.**

1eQ. Who is connecting the high voltage to the projection screens? **1eA.** The project's electrical contractor.

- 2Q. The equipment quantities provided in the specifications do not match the quantities outlined in the individual room equipment requirements for the various room types. IE: There are (2) Dalite 40782 projection screens listed however, there are at least (4) indicated in the various room types?
- 2A. New Screen purchases are required for the branch campus with an updated model number.
- 3Q. There are (5) projectors listed but, there are (13) included in the drawings?
- 3A. The existing projectors will be re-installed in the branch campus. Updated the quantity of new projector purchases.
- 4Q. There are (2) projection screens listed but, there are (13) included in the drawings?

4A. New Screen purchases are required for the branch campus with an updated model number.

5Q. The Specifications & Scope indicate that there are (2) USB Boundary Microphones in each room. However, the drawings include (3) Microphones in each room. How many microphones are required in each room?

5A. 2.

- 6Q. The equipment list includes (38) USB Extension adapters that we assume are for the microphones. However, the drawings include a total of (57) microphones. How many USB Extenders are required?
- **6A.** 38.

- 7Q. There are (17) Video Cameras listed. However, there does not appear to be any camera signal extenders. What is required for this?
- 7A. Each camera requires 1 Category 6A cable for power (PoE) and network connectivity.
- 8Q. There are (9) Audio amplifiers listed. However, (19) amplifiers appear to be required. How many amplifiers are needed?
- 8A. 9 new purchases; 10 existing amplifiers from current site will be installed in branch campus.
- 9Q. Are there any actual AV Drawings?
- 9A. Installation has been removed from this bid, see above changes to Scope of Work.
- 10Q. Will the AVC be responsible to provide engineering and auto cad drawings as part of the quote?
- 10A. Installation has been removed from this bid, see above changes to Scope of Work
- 11Q. Will there be a site visit for the requested services?
- 11A. No. Installation has been removed from this bid, see above changes to Scope of Work.
- 12Q. It's not clear how the equipment listed is to be interconnected and if additional equipment may be needed so a line drawing for each room is needed.

12A. Installation has been removed from this bid, see above changes to Scope of Work.

13Q. Attachment B is a partial equipment list without any audio signal processing and video switching. This hardware is usually the heart of the system operation AND where most field connections are made.

13A. Installation has been removed from this bid, see above changes to Scope of Work.

14Q. The other issue with Attachment B is that some of the items to be provided for the bid are house brand private label from B&H that no other vender can sell.

14A. Equal items may be accepted. The burden of proof of equality is the responsibility of the Bidder.

- 15Q. The Attachment C Scope of Work just lists the equipment from Attachment B and states for each item, "provide and install". We are looking for a written explanation of how all AV signals are routed and how users would engage with the installed hardware. An example is how all the listed Panasonic wireless microphones are used.
- 15A. Installation has been removed from this bid, see above changes to Scope of Work.

- 16Q. The drawings provided as part of Addendum #1 raised additional questions; an example who is providing all the projection screens? Why are so many projection screens shown on drawings E-301 & E-302 while only two projection screens are called for on the provided BOM in Attachment B?
- 16A. Installation has been removed from this procurement, so the drawings are no longer relevant. Please see Attachment B: Detailed Specifications for the updated list of equipment.
