2A: There are no A/V Drawings. A finalized Installation Scope of Work will be provided via an Addenda next week prior to the Site Visit.

3Q: Do you need to be an approved vendor to submit a sealed bid? If not, can you let me know what I need to do to be an approved vendor? Also, do we have to be an MBE or WBE company?

3A: The Dormitory Authority of the State of New York (DASNY) intends to procure AV equipment pursuant to its discretionary purchasing authority under Public Authorities Law Section 2879. This opportunity is intended for small businesses, as defined pursuant to Article 15-A of the New York State Executive law, and MWBE's certified pursuant to Article 15-A and, if applicable, businesses selling goods or technology that are recycled manufactured.

You do not need to be an Approved Vendor in order to submit a bid, however you must meet the requirements as a NYS Small Business and/or a NYS Certified MWBE Company.

Note: DASNY is in receipt of additional RFI's and will provide responses via Addenda.

All other terms and conditions of the original Invitation for Bids shall remain the same.
