Scope of Work

6 Months CommVault Master Certified Consulting Engagement.

CommVault Infrastructure

- Media Agents: CommVault Infrastructure includes CommServe, Media Agents, and Library. This is critical for the ability to restore during an encryption attack, and/or physical disaster. It is hard to estimate how much needs to be changed.
- CommVault Disaster Recovery: CommVault disaster recovery process ensures that
 two sites can be used to protect the CommVault data. It is extremely important for the
 process to be configured correctly, tested, and be continually tested. Rochester D/R
 site will use existing media server and a CommServer will be used.

CommVault Maintenance / Support

- Ongoing monitoring / maintaining the environment.
- Duration: 6 Months anticipate up 5 to 8 hours per week to monitor backup jobs, respond to requests for infrastructure team. Majority of requests from infrastructure team are not urgent and can be handled within 2 to 3 business days following the submission / email requesting a change or assistance with CommVault environment.

Training
